## **New Business:**

Bonnie presented a draft 23-24 budget and will make the necessary changes and bring it back to the June meeting for the final approval.

It was moved by B. Wavra, 2<sup>nd</sup> by R. Behm to increase the board's compensation from \$50/meeting to \$100/meeting effective July 2023. Motion carried.

There are two openings on the board for 23-24. B. Wavra and L. Abel's terms are up. L. Abel will run again, but B. Wavra will not since he has already served 3 consecutive terms. We are in need of more nominees to fill the open position. Notices have been published in the Echo and the Watch and the board members will contact some people that they think might be interested.

M. Moore reported on his research into bike trails around the lake. He said that Polk County might be able to obtain grant money from the state to build such trails. Rich Sanders will be invited to the June meeting to discuss this and also discuss some issues on the dam.

It was moved by R. Behm, 2<sup>nd</sup> by M. Moore to reimburse Bonnie for the time she spent on the Spring newsletter. Motion carried.

The Directory will be ready the week before Memorial Day and the board will deliver them again this year.
