



## **Operations Plan**

- 1. 8 (18'x50') heated bays to be rented out monthly with 6-month or 12-month contracts.
- 2. Each bay will have a standard 110v 20-amp outlet, One 110v 30-amp camper outlet, and lighting
- 3. No storage will be allowed outside the building
- 4. Customers can come and go all hours of the day
- 5. Building will be heated to a minimum 50deg throughout the winter
- 6. Monthly fees will include power and heat.
- 7. Property will be maintained and kept clean.
- 8. Storage units are meant for storage of personal property. No camping or overnight stays are allowed.
- 9. Customer is responsible for insurance on all personal property in the building.


